RE: California License Check System (CFLC)

As of July 1, 2008, California Penal Code Section 12072 (f)(1) prohibits all Federal Firearms Licensees (FFL's), other than Type 03 or 06 FFL's from shipping to an FFL in California unless prior to delivery, the FFL intending to deliver, sell or transfer the firearms obtains a verification approval number from the California Department of Justice (CADOJ) Bureau of Firearms. This includes transfers that occur at gun shows.

CVGS will refuse any firearm shipment that does not have an approval number written on the outside of the package.

To enroll in the CFLC system, you must have a valid FFL number. Enrollment is a one-time process. Enrollment can be done by internet or by mailing or faxing the application to the CA Bureau of Firearms.

To enroll by internet, use the link in the "Not yet enrolled in CFLC" section at <https://cflc.doj.ca.gov>. After completing the CFLC enrollment process, you will be able to log on to CFLC to obtain a Firearm Shipment Approval letter. Also, an enrollment acknowledgment email message containing your CFLC Log in ID and password will be sent to the email address entered on the enrollment screen.

To enroll by mail or fax. Complete the California Firearms License Check enrollment application and return it to the Bureau of Firearms via fax or mail. Once your application is processed, you will receive an enrollment confirmation letter that includes a telephone/fax number you can use to request Firearm Shipment Approval letters via fax or mail.
